***ROOM RESERVATION DEPOSIT:**

This deposit will be deducted from the student's room fee if he/she resides in the Residence Halls.

ALL fees for prior terms must be paid in full before a student may begin registration. West Virginia State University shall refuse graduation, transcript requests, registration privileges and grades until an account is paid in full.

FINANCIAL POLICIES:

Only the following alternatives will be accepted in lieu of full payment at registration for all fees and other charges.

One of the following must be in place by payment due date or upon registration:

- a. Students with financial aid packages of Federal Stafford Loans, Pell Grant, SEOG Grant, Perkins Loan and scholarships must give the university first lien of all funds received for semester or yearly expenses.
- b. Two payment plans are available in lieu of financial aid (available for Fall and Spring terms only)
*60/40 Plan- first payment of 60% of the tuition plus course fees, parking fee due upon registration. Remaining 40% due with a 2% interest fee is due six weeks after the first day of classes. Interest on the deferred amount may be charged at a rate not to exceed the legal limit.
*Monthly Installment through Sallie Mae-visit TuitionPaymentPlan.com/Enroll to sign up.
This plan is not a loan and payments are made directly to SallieMae.
- c. Third Party payment authorizations.

Important Notes

1. A returnable Room Breakage Deposit of \$100.00 is required of all new students upon admission to a residence hall at West Virginia State University.
2. Damage to furniture, fixtures, and the building shall be assessed against the individual student causing such damage. When University officials are unable to determine the offender, the cost of such damage shall be assessed against the students residing in the room, section, or residence hall, as circumstances require.
3. An extra charge shall be levied whenever the University finds it necessary to clean a particular room because of the delinquency of its resident.
4. A student's registration may be canceled when payment is made by a check which is dishonored by the bank. A Returned Check Service Fee of \$25.00 shall be made for dishonored checks.
5. Special attention is called to the following order of the West Virginia Higher Education Policy Commission. "No diplomas, certificates of attendance, or credits, and no participation in graduation exercises shall be extended to any students until all delinquencies, balances, or charges on the books of the institution against such students shall be paid in full."

No financial credit of any type shall be extended to any individual, either student or other, at any state university or college. All universities and colleges shall operate on a strictly cash basis with all payments and obligations being collected in advance except that room and board charges may be divided into installments as determined by the institution. A student is not considered registered until full fee payment has been made.

Exceptions may be granted where a bona fide third party agency has provided authorization in writing that payment will be made for the student.

REFUND POLICY FOR STUDENTS WHO WITHDRAW

A student who officially withdraws from the University (i.e. drops all classes through the Office of Registration & Records or is administratively withdrawn from college prior to completing 50% of a semester is entitled to a partial refund of that semester's tuition/fees. Refund amounts are calculated to be based on the number of calendar days which have elapsed from the first day of class to the date of withdrawal. The date of withdrawal is the actual date the student notifies the Office of Registration & Records of withdrawal. Any student who withdraws at any point during the semester is advised to consult with the Cashier's Office to determine whether there is a balance owing or refund due.

Tuition is not adjusted for "reducing a schedule" after the add/drop period.

For a student receiving federal financial aid who withdraws before completing 60% of the semester, the amount of federal financial aid earned will be calculated to the day according to the same formula. Unearned financial aid must be returned. When aid is returned, the student may owe a balance to the college, to the U.S. Department of Education, or to both. Any student receiving federal financial aid would contact the Office of Student Financial Assistance before withdrawing from college or reducing the number of hours enrolled to determine the impact of these actions on his or her financial aid status.

Refunds are calculated from the first formal day of registration. Refunds will not be processed until after the end of the refund period.
