Mitigating measures do not include ordinary eyeglasses or contact lenses.			
Does the impairment substantially limit a major life activity as compared to most people in the general population? Note: Does not need to significantly or severely restrict to meet this standard. It may be useful in appropriate cases to consider the condition under which the individual performs the major life activity; the manner in which the individual performs the major life activity; and/or the duration of time it takes the individual to perform the major life activity, or for which the individual can perform the major life activity.
