



Job Title: ANR Extension Educator – Natural Resources & AgriTourism

Job Summary

The full-time Extension Educator, Agriculture and Natural Resources (ANR) is responsible for planning, delivery and evaluation of educational programming of particular interest to Natural resources to include water quality and how we use our West Virginia natural resources to establish and maintain agritourism businesses throughout the state. Working with the Program Leader, the educator will be responsible for ANR program delivery in the following counties in West Virginia; Clay, Nicholas, Fayette & Summers. As an Extension employee, the individual must be willing to continue professional development applicable to the program efforts. The incumbent is expected to perform other tasks that may be assigned by supervisor(s) and work cooperatively with stakeholders and other Extension team members at the county, regional, state and national levels. This position is employed by the West Virginia State University Research and Development Corporation.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

Program Development, Reporting and Fiscal Management

- Work with program staff, and evaluators on grant reports
- Promote the ANR programs at local and statewide events
- Create monthly and annual reports for the ANR Program Leader and administrators of WVSU and the WVSU Research and Development Corporation.
- **Educational Program Development and Delivery**
- Coordinate the delivery of various WVSUES programming with including but not limited to agriculture sustainable practices.
- Develop community-based events, workshops and training experiences
- Collaborate with local, state, and national educational outreach programs to enhance educational workshops and outreach activities
- Create curricula appropriate for WVSUES programming

Technical Assistance

- Provide field expertise to community and partners
- Serve on community boards and committees

- Participate in community events

Other Duties as Assigned

Supervisory Responsibilities

Responsibilities of the position include: management of project team partners to achieve designated benchmarks; recruit, interview, and retain community volunteers. Position may, at times, supervise extension, Interns, and student workers.

Qualifications

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

The individual must be experienced in communicating with agriculturalists, stakeholders and agency partners and be able to work independently, often in the field, and with minimal supervision. The individual must exhibit a willingness to work collaboratively and have capacity for flexibility. Must possess a valid driver's license in good standing.

Required Education and Experience

A Bachelor's degree is required, Masters preferred in agriculture, natural resources, biological sciences or closely related field. The successful candidate will have strong written and oral communication skills and experience in working with diverse clientele and organizations.

Computer Skills

To perform this job successfully, an individual should have knowledge of database software, Internet software, and word processing software.

Travel

Travel state-wide but may also include various portions of the United States based on attendance requirements for training and/or reporting for grant purposes.

Position Type and Expected Hours of Work

This is a full-time position. Days and hours of work are Monday through Friday, 8:30 AM to 5 PM. Summer Schedule is Monday through Friday 8:00 AM to 4:00 PM. However, due to the nature of work performed, flexible hours, including evenings, weekends and occasional overnights are required.
