Colleges Build Local Economies

According to a report by the WVU Bureau of Business and Economic Research, West Virginia's 12 four-year institutions and nine two-year institutions supported 22,000 jobs. Compensation in supporting those jobs was reported at \$1.4 billion. Economic impact for individual institutions ranges from \$5.6 to \$1.4 billion. That activity generated more than \$60 million in tax revenue for the state.

When combined with tuition, student spending and other sources of revenue, the economic impact of the institutions was nearly seven times the amount of the state's appropriation for the schools. Even smaller institutions have an economic impact as an economic driver for many communities.

Graduates contribute more, too. According to the Brookings Institute in 2015, those with bachelor's degrees contribute over their lifetimes more than \$250K to their local economies and over \$40K in state & local taxes.* Those with associate's degrees contribute over \$80K to their local economies.


