

\$1,000,000,000 PLAN 6% INFLATION = +\$60,000,000 EVERY YEAR

RESERVE FUND

PEIA HAS DRAWN DOWN THE RESERVE FUND THE PAST FEW YEARS.

BY LAW, THE RESERVE FUND CANNOT GO BELOW A CERTAIN LEVEL.

THERE IS NO HELP THIS YEAR FROM THE RESERVE FUND.

NO ADDITIONAL FUNDS FROM THE LEGISLATURE

SCENARIOS

- RAISE PREMIUMS FOR EVERYONE IN ORDER
 TO DISTRIBUTE THE PAIN EQUITABLY
- NO. BECAUSE OF THE 80/20 RULE, WE CANNOT RAISE PREMIUMS

SCENARIOS

- CHANGE THE 80/20 LAW TO 70/30.
- NO BECAUSE WE RISK 70/30 BECOMING 60/40, THEN 50/50 AND WORSE.

- CHANGE THE LAW SO THAT THE LEGISLATURE MUST CONTRIBUTE A CERTAIN DOLLAR AMOUNT PER PARTICIPANT.

- TAKE ACTION
- ATTEND PEIA OPEN HEARINGS EN MASSE
- PRESSURE YOUR LEGISLATORS TO ATTEND THE OPEN HEARINGS

EDUCATE

- ENCOURAGE LOCAL LEGISLATORS TO ATTEND OPEN PEIA HEARINGS
