## West Virginia State University Office of Financial Aid and Scholarships 2025-2026 Verification Worksheet

You must complete and sign this worksheet, attach any required documentation, and submit to the Financial Aid Office. If you are a dependent student, at least one parent must sign this worksheet. Based on your answers on this worksheet, we may ask for additional information. If you have questions about verification, contact our office as soon as possible to avoid delays with your financial aid.
