#### I. Call to Order

Governor Kelley called the meeting to order at 1:40 p.m.

#### II. Roll Call

The clerk called the roll. Members present were Governor Flores, Governor Greenhowe, Governor Jordan, Governor Kelley, Governor McClung, Governor Pietruszynski, and Governor Saffore. Members absent were Governor Marcum, Governor McKibben, Governor Payne, Governor Raines and Governor Sprouse.

#### III. Verification of Appropriate Notice of Public Meeting

Governor Kelley verified the Appropriate Notice of Public Meeting.

#### IV. Approval of Meeting Minutes

Governor Kelley asked for a motion to approve the minutes from the December 12, 2024 meeting. Governor Pietruszynski so moved, and Governor Greenhowe seconded the motion. The motion carried.

#### V. Deferred Maintenance Re-Appropriation

Justin McAllister presented on proposed re-appropriation of deferred maintenance funds to reprioritize certain projects. Governor Kelley called for a motion to approve the request to reappropriate the deferred maintenance as presented. Governor Pietruszynski so moved, and Governor Saffore seconded the motion. The motion carried.

#### VI. 2025-2026 Tuition & Fees Schedule

Justin McAllister presented on the proposed 2025-2026 Tuition & Fees Schedule. Following indepth discussion, Chair Kelley called for a motion to approve the schedule as presented to the Board. Governor Greenhowe so moved, and Governor Pietruszynski seconded the motion. The motion carried.

Debbie Williams presented on three academic programs that are up for review – Bachelor of Arts in English, Bachelor of Science in Biology, and Master of Science in Biotechnology – all of which were recommended to be continued at their respective current level of funding. Chair Kelley called for a motion to approve the three program reviews as presented. Dr. Pietruszynski so moved, and Governor Saffore seconded the motion. The motion carried.

#### VIII. Report from the WV Advisory Council of Faculty

Dr. Barbara Ladner presented information on the purpose the State Advisory Council on Faculty and highlighted the work that they do on behalf of faculty throughout the state.
